REGULAR MEETING

Township Meeting Minutes

03-3-2015

The Board of Duchouquet Township Trustees met in regular session on the 3rd day of March at 7:00 P.M. at the Township Meeting Room located at 16038 25A Dixie Highway, Wapakoneta, Ohio, Auglaize County.

President, John Limbert, called the meeting to order. Roll call was:

Also present were: Representative from Fire Departments from Uniopolis, Cridersville, Buckland, and Wapakoneta.

Other Guest: Brian Vernon, Sheriff Dept.

The fiscal officer gave the minutes and financial report of the regular meeting of February 3rd Bruce Rohrbacher made a motion to accept the reports as given. Dwight Steinke seconded the motion; motion carried.

Dwight Steinke made a motion to enter into agreements with the four fire departments, Wapakoneta City Fire Dept Fire Dept., and the Village of Buckland Fire Dept. to provide fire and rescue service to the areas as described for the Duchouquet Township for a period from April 1, 2014 thru March 31, 2015. Each department will receive the following revenue:

Dwight Steinke made a resolution to appoint the Duchouquet Fire Prevention Officer as Kelly Knoutz, Uniopolis Fire Chief for the territory other than what Cridersville will be covering. Bruce Rohrbacher seconded the motion; motion carried.

Dwight Steinke made a resolution to appoint the Cridersville Fire Department designed fire prevention officers for the territory that they cover which is the north part of our township. Bruce Rohrbacher seconded the motion, motion carried.

Tom Doorley was not in attendance but sent paper to address with the Board:

Letter of zoning violation was mailed to Dusty Butler at 15133 Blank Pike for the numerous vehicles parked on property. The new owner of the McCleary property on National Road in Cridersville request a change to the zoning map to C-1 Commercial for the construction of a 900 foot building to be used for an indoor shooting range.

Dwight Steinke made a motion to have the Cridersville Boy Scouts and Auglaize County Shootin pick up trash on the township side ditches at rate of \$15.00 per mile. Bruce Rohrbacher seconded the motion. Roll call vote was all yes. Motion passed.

The Fiscal Officer reviewed the 2016 Budget to be filled with the Auglaize County Budget Commission per House Bill 194. Dwight Steinke approved the budget and Bruce Rohrbacher seconded the motion. Roll call was:

The fiscal officer informed the Board on the County Meeting and Hog Roast that will be on March 26th.

The Board discussed the Clean Ohio Fund Green Space Conservation Program meeting to be held on March 9 at 9 AM at the County Commissioners Office. Cathy and Dwight will attend this meeting to see if could be used for the park

project. There is also a meeting at 10AM on the Community Development Block Grant (CDBG) that they will also attend.

The Fiscal Officer discussed with the Board on the current changes being made by the ACA(Affordable Care Act) on the employer reimbursement for health care premiums which is no longer acceptable under ACA. Cathy wants to stop reimbursement till she gets more information and advice on this new change.

Cathy asks for a motion to change the next regular meeting from April 7 to April 2nd at 9:00 AM. Dwight Steinke made a motion, Bruce Rohrbacher seconded; motion carried.

Having no further business Bruce Rohrbacher made a motion to adjourn the meeting. Dwight Steinke seconded the motion; motion carried.
