

**DUCHOUQUET TOWNSHIP
REGULAR MEETING
Township Meeting Minutes**

03-4-2014

The Board of Duchouquet Township Trustees met in regular session on the 4th day of March at 7:00 P.M. at the Township Meeting Room located at 16038 25A Dixie Highway, Wapakoneta, Ohio, Auglaize County.

President, John Limbert, called the meeting to order. Roll call was:

Also present were: Representative from Fire Departments from Uniopolis, Cridersville, Buckland, and Wapakoneta.

The fiscal officer gave the minutes and financial report of the regular meeting of February 4th Bruce Rohrbacher made a motion to accept the reports as given. Dwight Steinke seconded the motion; motion carried.

Dwight Steinke made a motion to enter into agreements with the four fire departments, Wapakoneta City Fire Dept Fire Dept., and the Village of Buckland Fire Dept. to provide fire and rescue service to the areas as described for the Duchouquet Township for a period from April 1, 2014 thru March 31, 2015. Each department will receive the following revenue:

Resident Richard Alt was present to voice his concern on the Cridersville Truck Mud operation that is in his backyard in Cridersville. Tom informed him of the actions we have in process and he thanked us and excused himself from the meeting.

Dwight Steinke made a resolution to appoint the Duchouquet Fire Prevention Officer as Kelly Knoutz, Uniopolis Fire Chief for the territory other than what Cridersville will be covering. Bruce Rohrbacher seconded the motion; motion carried.

Dwight Steinke made a resolution to appoint the Cridersville Fire Department designed fire prevention officers for the territory that they cover which is the north part of our township. Bruce Rohrbacher seconded the motion, motion carried.

Tom Doorley discussed with the Board:
Matthew McCreary failure to properly complete the permit application and application for Conditional Use Permit that a letter has been set to him on Feb 24 giving Matthew till March 10th to submit the additional information or the application will be returned to him with his payment of \$240.00. The Board asks the fiscal officer to process the check and get to Tom Doorley to handle this situation. Tom and attorney have filed a complaint and the hearing date is March 6.

Dwight Steinke made a motion to have the Cridersville Boy Scouts and Auglaize County Shootin pick up trash on the township side ditches at rate of \$15.00 per mile. Bruce Rohrbacher seconded the motion. Roll call vote was all yes. Motion passed.

The Board discussed having the Auglaize County Engineer Department spray all the township road ways, except Oakwood Hills and decided not to have this done this year.

The fiscal officer, Cathy Oen, informed the Board that she attended a certified Public Records Training on Feb 24, 2014 fulfilling the requirements under Ohio Revised Code Section 109.43.

Dwight Steinke made a resolution to endorse the passage of the Issue I and ask the citizens of Auglaize County to support with their vote the Issue 1 at the May Primary and continue the program for another 10 years in order to provide much needed dollars for the reconstruction of road, bridges and sewer systems throughout Auglaize County. Bruce Rohrbacher seconded the motion. Roll call was:
