REGULAR MEETING

SEPTEMBER 2, 2014

The Board of Duchouquet Township Trustees met in regular session on this 2nd day of September 2014 at 8:00 P.M. at the Township Meeting Room located at 16038 N. Dixie 25A, Wapakoneta, Ohio, Auglaize County.

The meeting was called to order by President, John Limbert. Roll call was:

Bruce Rohrbacher made a motion to accept the minutes of August 12th regular meeting and the financial reports as given by the Fiscal Office. Dwight Steinke seconded the motion; motion carried.

Tom Doorley represented the Board with several permits. He also informed the Board on:

1. Tom McCreary property with the mud activity is under contract to sell and the operation is stopped. He was only fined \$250.00 by the court.
2. Charlie O'Dell at 5 Hermitage in Cridersville. In 2002 got permit for the pool and fence. Now the property is not mowed and the fence is down and the pool is not in use. Have complaint from Dewayne and Cindy west. Tom is sending and letter to owner.

Dwight Steinke made a motion to keep the township insurance plan with OTARMA. The renewal price this year is \$10,637. Bruce Rohrbacher seconded the motion. Motion passed with all favorable roll call votes.

Bruce Rohrbacher moved the adoption of the following resolution: RESOLVED, By the Board in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing Jan 1, 2015 and WHEREAS, The Budget Commission of Auglaize County has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within, the ten mill limitation;

therefore, be it RESOLVED, By the Board that the amounts and rates as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further RESOLVED, That there be and is hereby levied on the tax duplicate of said Township the rate of each tax necessary to be levied within and without the ten mill limitation as follows: General Inside 2.00 mill will generate \$45,607 Road & Bridge 2.75 inside mill will generate \$167,480 and Fire District 2.00 mill outside will generate \$121,803 and be it further RESOLVED, that the Fiscal Officer of this Board be and she is hereby directed to certify a copy of this resolution to the County Auditor of Said County.
