

**DUCHOUQUET TOWNSHIP  
REGULAR MEETING  
OCTOBER 6, 2015**

The Board of Duchouquet Township Trustees met in regular session on this 6th day of October, 2015 at 8:00 P.M. at the Township Meeting Room located at 16038 N. Dixie 25A, Wapakoneta, OH, Auglaize County.

The Minutes and financial reports were given by the Fiscal Officer from the September 1<sup>st</sup> regular and special Zoning Resolution Amendment meetings. Dwight Steinke made a motion to accept the reports as given. Bruce Rohrbacher seconded the motion; motion carried.

Tom Doorley, Zoning Inspector, had five permits this month. Tom informed the Board that Amber Neal at 7 Amy Avenue, Cridersville has put water in her pool with the fence incomplete. Upon rechecking the fence he found the fence up but there is space under the fence to allow a child to pass thru. He is working on this situation.

Tim Myers and his builder Rick Kantner were present to Request what can be done to start construction on his home on Ramga Road. Tom, Inspector, is not able to give him a permit to build due to Myers not able to obtain and septic permit. They want us to waive this requirement due to the possibility that his lot may be annexed into the city and they want city water and sewage. Tom informed them that he will not give a permit. They are going to take legal action with attorney to try to change this decision. Tom informed them his attorney will have to contact Ed Pierce our legal counsel. Tim Myers has also built an accessory shed on the property without a permit. The building was built by Shockman Lumber. Myers now needs a variance for a conditional use, for the building without a residence. Per Myers the paperwork and check is in the mail to Tom.

Dwight made a resolution to continue the township's liability, property, and auto insurance with OTARMA at an annual rate of \$10,197.00. **Bruce seconded the motion; motion carried.**

**Bruce Rohrbacher made a resolution to approve the plan as adopted by the Auglaize County Solid Waste Management District. Dwight Steinke seconded the motion; motion carried. Attached is the complete resolution to the plan.**
