Township Meeting Minutes**

The Board of Duchouquet Township Trustees met in regular session on the 8<sup>th</sup> day of March at 7:00 P.M. at the Township Meeting Room located at 16038 25A Dixie Highway, Wapakoneta, Ohio, Auglaize County.

The fiscal officer gave the minutes and financial report of the regular meeting of February 2<sup>nd</sup>. Dwight Steinke made a motion to accept the reports as given. Bruce Rohrbacher seconded the motion; motion carried.

The guests from the Village of Cridersville were present to discuss with the Board the proposed program called SiteOhio. This program certifies sites and building pipeline sites for Ohio's future capacity. The proposed industrial park site is Interstate 75 at National Road in Cridersville. The committee has already gotten six property owners that want to put enter into this project with their property. The total acres will be 53.553. The six property owners are Eugene Winegardner, Craig McKercher, Linda Welker and Debra Hopkins, Marlene Howell, Rick Williams and Steve and Deb Grimes. The Village informed the Board that there is much work to do on the project yet but the filing date was March 1 to be able to get aboard this project. They are here wanting to inform the Township Board and are asking that the Township Board agree that if and when the industrial parks is developed that the Township will agree to the annexation that will be necessary to continue the development. After discussion Bruce

Rohrbacher made a motion to be in favor of the annexation and Dwight Steinke 2<sup>nd</sup> the motion. Roll call vote was all in favor.

Dwight Steinke made a motion to enter into agreements with the four fire departments, Wapakoneta City Fire Dept Fire Dept., and the Village of Buckland Fire Dept. to provide fire and rescue service to the areas as described for the Duchouquet Township for a period from April 1, 2016 thru March 31, 2017. Each department will receive the following revenue:

Bruce Rohrbacher made a resolution to appoint the Duchouquet Fire Prevention Officer as Kelly Knoutz, Uniopolis Fire Chief for the territory other than what

Cridersville will be covering. Dwight Steinke seconded the motion; motion carried.

Dwight Steinke made a resolution to appoint the Cridersville Fire Department designed fire prevention officers for the territory that they cover which is the north part of our township. Bruce Rohrbacher seconded the motion, motion carried.

Tom Doorley had two permits. Tom also informed the Board that Poggemeyer Design Group will be updating the Zoning Map with the amendments needed, and update the Zoning text with amendments needed and provide an electronic version of both. The cost will be \$850.00 Dwight made a motion to approve this and Bruce Rohrbacher seconded the motion. Motion carried.

Dwight Steinke made a motion to have the Cridersville Boy Scouts and Auglaize County Shootin pick up trash on the township side ditches at rate of \$15.00 per mile. Bruce Rohrbacher seconded the motion. Roll call vote was all yes. Motion passed.

Bruce Rohrbacher made a motion to purchase a heated power washer from Enzo's Cleaning for \$4750 state bid price which retails for \$7830. Dwight Steinke seconded the motion; motion carried.

The Fiscal Officer reviewed the 2017 Budget to be filled with the Auglaize County Budget Commission per House Bill 194. Dwight Steinke approved the budget and Bruce Rohrbacher seconded the motion. Roll call was:
