Township Meeting Minutes
February Meeting

The Board of Duchouquet Township Trustee met in regular session on this 31st day of January @ 7:00 P.M. at the Township Meeting Room located at 16038 25A Dixie, Wapakoneta, Ohio, Auglaize County.

The minutes of the Special End-of-the Year Meeting, Special Re-organizational and Special Annual Appropriations Meeting, Special Zoning Resolution Amendments minutes were read. Dwight Steinke made a motion to approve the minutes as given. Bruce Rohrbacher seconded the motion; motion carried.
