REGULAR MEETING

APRIL 4, 2017

The Board of Duchouquet Township Trustees met in regular session on this 4th day of April 2017 at 7:00 P.M. at the Township Meeting Room located at 16038 Dixie Highway, Wapakoneta, Ohio, Auglaize County.

The March 7th minutes and financial reports were given by the Fiscal Officer. Dwight Steinke made a motion to accept the reports as given. Bruce Rohrbacher seconded the motion; motion carried.

Tom Doorley reported to the Board:

1. He had 2 permits to turn in.
2. Rulan Smith, from Triskele LLC, gun facility in Criddersville, was present. He discussed with the Board wanting us to sign a resolution for an expedited annexation approval into the Village of Criddersville. He informs us that due to a Hotel now being included in the project that he is required to have city water and sewage.
3. Tom also had a letter to Nancy and Glen Smith on Hengstler Road for a violation of two vehicles requesting current registration and prove that vehicles run.

Strip seal 4', Fog and Edge line

CEMETERY ROAD

0.2 miles, Curve,

Full seal, Fog, Centerline and Edge line

TOWNLIME LIMA ROAD

0.5 miles, split with Union Twp., from Middle Pike to Rt 33

Full seal, Fog, Centerline and Edge line
