REGULAR MEETING

JUNE 6, 2017

The Board of Duchouquet Township Trustees met in regular session on this 6th day of June 2017 at 8:00 P.M. at the Township Meeting Room located at 16038-25A Dixie Highway, Wapakoneta, Ohio, and Auglaize County.

The Fiscal Officer gave the minutes of the regular May 2nd meeting and the financial reports. Bruce Rohrbacher made a motion to accept the reports as given. Dwight Steinke seconded the motion; motion carried.

The Sheriff Deputy was present to review the marijuana new laws and make trustees aware of the option to prohibit it in the township. The fiscal officer informed them that Ed Pierce had sent us a sample resolution on this action. The board discussed to take no action now.

Tom had five building permits to review with the Board.

Ted Hemleben was present to discuss with Tom and the Board on his request to amend and revise the zoning from agricultural to general commercial for 3.687 acres property located at 15115 State Route 67. The current Catalina Hotel he wants to change to a Dance Studio.

Chad Scott, from the City of Wapak, was present to review the annexation of 20.296 acres to the City filed by David Schlenker for property on Ramga Road. Chad stated to the Board his concerns with the current road width. The Board informed him that the township would not be doing any upgrades to the existing roadway.

Bruce Rohrbacher made a motion to ask the Fiscal Office to advertise to change the next two months meeting dates. July 4 change to July 11 due to holiday and August 1 change to August 8 due to Auglaize County Fair. Dwight Steinke seconded the motion. Motion carried.

The Board ask Fiscal Officer to check with Doug Rinehart to make sure the sign order has been submitted to the State.

Bruce Rohrbacher made a resolution to continue with the authority to reimburse for health care as clarified in Bulletin 2017-002 and to transfer \$26,000 in the Road and Bridge fund from acct # 2031-330-360 to 2031-390-220 to allow for the insurance out of pocket reimbursement to the township elected officers.
