**RESOLUTION REQUESTING
THE COUNTY AUDITOR TO CERTIFY TAX LEVY
VALUATIONS AND REVENUE**

The Board of Township Trustees of Duchouquet Township, Auglaize County, Ohio met in regular session on the 2nd day of April, 2019 at the office of the Township with the following members present:

Mr. Place

Mr. Rohrbacher

Mr. Dwight Steinke moved the adoption of the following Resolution:

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Duchouquet Township, Auglaize County, Ohio, and

WHEREAS, the previously voted two mil, five year levy for the purpose of the payment of fire fighting companies and to provide ambulance or emergency medical services operated by a fire fighting company for Duchouquet Township, approved in 2014, will terminate with tax year 2019, and

WHEREAS, the Board of Township Trustees of Duchouquet Township, Auglaize County, Ohio believes it may be necessary to levy a tax in excess of the ten mill limitation for the benefit of Duchouquet Township for the purpose of the payment of fire fighting companies and to provide ambulance or emergency medical services operated by a fire fighting company; pursuant to Ohio Revised Code §§5705.19(I) and §5705.191.

THEREFORE BE IT RESOLVED that the Board of Township Trustees of Duchouquet Township requests that the Auglaize County Auditor certify to this Board the current tax valuation of the subdivision and the amount of the revenue that would be produced by a two (2.0) mill levy, outside the ten-mil limitation, for the purposes stated above.

BE IT FURTHER RESOLVED said levy is being considered to being placed on the November 5, 2019 General Election as a replacement levy, for a period of five years to be placed on the tax list beginning with the 2020 tax year and collection beginning in 2021.
