

Estimated Property Tax Revenue from the Auglaize County Auditor. The estimated property tax revenue that will be produced by the stated millage is \$152,960. The levy type is a 5-year replacement to be placed on the ballot at the November 5, 2019 election. Attached is a copy of the certification.

## Certificate of Estimated Property Tax Revenue

(Use this form when a taxing authority certifies a millage rate and requests the revenue produced by that rate.)

The County Auditor of **Auglaize** County, Ohio does hereby certify the following:

1. On **April 3, 2019** the taxing authority of Board of Township Trustees of Duchouquet Township, certified a copy of its resolution adopted **April 2, 2019**, requesting the County Auditor to certify the current tax valuation of the subdivision and the amount of revenue that would be produced by **two (2.0) mills**, to levy a tax outside the ten-mill limitation for **Fire and Emergency** purposes pursuant to Revised Code {**5705.19(I)**} to be placed on the ballot at the **November 5, 2019** election. The levy type is **replacement**.
2. The estimated property tax revenue that will be produced by the stated millage, Assuming the tax valuation of the subdivision remains constant throughout the life of the levy, is calculated to be **\$152,960**.
3. The total tax valuation of the subdivision used in calculating the estimated Property tax revenue is **\$76,457,790**.
