The Board of Duchouquet Township Trustees met in regular session on the 3RD day of March at 7:30 P.M. at the Township Meeting Room located at 16038 25A Dixie Highway, Wapakoneta, Ohio, Auglaize County.

Dwight Steinke made a motion to have the Cridersville Boy Scouts and Auglaize County Shootin pick up trash on the township side ditches at rate of \$15.00 per mile. Rick Place seconded the motion. Roll call vote was all yes. Motion passed.
